Qualification: MBBS with P.G. Degree/Diploma/DNB in the concerned specialty from a recognized University/Institution and should have a valid registration with Delhi Medical Council. Must not have completed 03 years Senior Residency in any recognized institution including regular & ad-hoc period.

<u>Pay Scale:</u> As per 7<sup>th</sup> CPC Pay matrix level 11, Pay Rs. 67700/ plus allowances as admissible under the rules.

<u>Age Limit:</u> 45 years for General, 5 years relaxable for SC/ST and 03 years for OBC candidates (belonging to Delhi only) on the closing date of submission of application.

#In case of non-availability of SC/ST/OBC candidates, the post shall be filled from General Category.

<u>Tenure:</u> The tenure of Senior Residents is for a period of three years including any service rendered as Senior Resident earlier on ad-hoc/ regular basis in any recognized institution. The appointment will be initially for a period of one year that can be extended further upto a maximum period of 03 years subject to satisfactory performance, work and conduct report from concerned HOD.

Further, in case of non availability of candidates, as per the relevant scheme mentioned above, candidates may be considered in terms of the relaxation of provision as per circular No. F.121/26/2010/H&FW/1996-2045 dated 10.06.2011 of Deptt. of H&FW, GNCT of DeIhi with the following relaxation:-

- 4. Upper age limit for eligibility for SR will be 45 years.
- 5. In case of non availability of fresh candidates, candidates who have completed 03 years of Residency as Senior Residents may also be allowed to appear in the interview.
- 6. Separate merit lists for fresh candidates and for other (i.e. those who have already completed 3 years of Sr. Residency) would be prepared.

- 7. First, the list containing the names of fresh candidates would be exhausted for appointment and the second list would be used only after that.
- 8. All appointments for Senior Resident from second list will be for one year only. It would not be renewable after one year.

## Other conditions/requirements:-

- 1. The candidates who are already in govt. service should submit an NOC from his/her employer.
- 2. Candidates are required to bring all original certificates and testimonials along with two passport size photographs on the date of interview.
- 3. The posts will be filled up in phases as per availability of vacancies and as per need of the department. The number of vacancies as shown above may subject to change.
- 4. Appointment shall be subject to medical fitness & verification of certificates.
- 5. No TA/DA will be paid for appearing in the interview.
- 7. Candidate having 2.5 years experience as Junior Residents in concerned specialty can also apply for the post of Senior Resident ship on ad-hoc basis as may be considered if no candidate with degree/diploma appearing for interview.
