<u>Terms of Reference for the post of National Mission Manager- Enterprise</u> <u>Promotion for DAY National Rural Livelihood Promotion Society</u>

The Government of India has launched DAY--National Rural Livelihoods Mission (DAY-NRLM) under the Ministry of Rural Development (MoRD). The mission aims at creating efficient and effective institutional platforms of the rural poor enabling them to increase household income through sustainable livelihoods and improved access to financial and public services. The DAY-NRLM's budget for supporting non- farm livelihoods of the SHG members is Rs.3000 crores till 2025-26. To implement the mission, GoI has constituted National Rural Livelihood Promotion Society (NRLPS) to provide Technical Assistance to all states. A multidisciplinary professional team, has been constituted in NRLPS. This team consists of senior professionals, experienced consultants and young professionals among others. In light of above, Rural Livelihoods Division requires to invite application for the service of professional expert at Level 1 for the post of **National Mission Manager- Enterprise Promotion** at NRLPS, New Delhi.

L1 National Mission Manager- Enterprise Promotion	Candidates with a Post-Graduation degree or full time 2 years Diploma in management from an institute of national and international repute or professional degree like CA, ICWA, ICFAI	Essential requirements: Minimum 15 years of experience out of which S/he must have at least 5 years' experience at a middle/senior management level of working in operations for profit enterprise / in implementing non-farm/ off Farm livelihood interventions in the government sector or CSR or not for profit sector. Desirable: Preference shall be given to: experience of managing a large-scale program in livelihoods promotion for rural poor and /or experience in enterprise promotion, business advisory services, forward and backward linkages. Programme management skills with experience counted in terms of ability to navigate procurement of partners, managing partnership with them and leading a dispersed team of



experience professionals/experts, etc are desirable.

The person should also have experience in designing and handling large scale training programs for community and staff.

The person should have clearly established track record of working with poor communities and promoting their livelihoods.

The person should have strong Data based decision making and data analysis skills.

Should have excellent negotiation, interpersonal, and communication skills and should have displayed a problem-solving attitude.

Experience in Marketing and branding product is desirable.

Job Description:-

- The position is for a person who shall drive the promotion of and support to the nonfarm enterprises of the NRLM SHG members.
- The incumbent shall be responsible for successful implementation of the programmes, including providing technical guidance to the states and the implementation agencies and partners.
- S/he shall be responsible for meeting the financial and physical targets of the programmes (on both quantitative and qualitative parameters) and ensuring that the supported enterprises are profitable and financially sustainable.
- S/he shall facilitate partnerships with multiple stakeholders, financial institutions, CSR
 organizations, support organizations, training organizations, NGOs, marketing and ecommerce agencies and government line departments for achieving program
 objectives.
- Shall lead and drive a culture of support to enterprises of the poor within the NRLM
 eco-system, including giving suggestions on policy changes for ensuring that these
 enterprises of the poor, reach scale are financially sustainable and provide enhanced
 incomes to the members of the community engaged with these enterprises.

Please note the Professionals hired by National Rural Livelihood Mission would be through Human Resource Management Agency. Based on performance and requirement of NRLPS, the tenure of the position may further be extended.
