You will work with the National Jal Jeevan Mission at Centre for Water Policy and Governance in the area of decentralized (rural) drinking water governance, capability building, community participation and relevant themes. Your work would also involve managerial duties including accounts, maintaining communication with donors, organizing workshops, policy roundtables, and training events.

Key Responsibilities:

- Organize events, such as workshops, policy-roundtables (online and offline), meetings and manage activities and tasks.
- Prepare progress reports and maintain required documentation and communication with Department of Drinking Water and Sanitation and other partners of the project
- Support the PI/Co-PI in the administrative management of the project including project accounts and management of website.
- Participate and contribute to the research and outreach activities suggested by PI/Co-PI
- Undertake travel as per the requirements across Indian states for collecting data and monitoring data collection done by local project partners or project associates.
