General Instructions / Conditions:

- 1. Indian Nationals (Eligible candidates) have to apply through "Online Application Portal (OAP)" of the Ministry of Ports, Shipping and Waterways (http://onlinevacancy.shipmin.nic.in). While applying for the post, the applicant should ensure that he / she fulfills the eligibility and other norms mentioned above. In case, it is detected at any stage of recruitment that a candidate does not fulfill the eligibility norms and / or that he / she has furnished any incorrect / false information or has suppressed any material fact(s), his / her candidature will stand automatically cancelled. If any of the above shortcoming(s) is / are detected even after appointment, his / her services are liable to be terminated without any notice.
- 2. All qualifications should be recognized and approved in India by AICTE / UGC / appropriate Statutory Authority / Competent Authority.
- 3. The mere fact that a candidate has submitted the application against the advertisement would not bestow upon him / her the right to be called for written test / interview / considered for selection process.
- 4. Employees working in Central & State Government / Semi-Govt./Govt. Autonomous Bodies/CPSEs must apply through proper channel or submit No Objection Certificate at the time of interview.
