



Vacancy Notification for the post of SRF (Ayurveda) (1) and Lab Technician (1) under research project funded by Central Council for Research in Ayurvedic Sciences (CCRAS)

Eligible candidates are invited to attend Written test/ interview on dates mentioned below for the post of **Senior Research Fellow/SRF (Ayurveda) and Lab Technician** on purely **contractual basis** in the extramural research project titled “*Prospective, Randomized, Open-Label, Blinded End Point exploratory clinical study to evaluate the efficacy and safety of Ayurvedic regimen as an adjunct to Hydroxyurea in the management of Sick cell disease*” funded by Central Council for Research in Ayurvedic Sciences (CCRAS), New Delhi, Ministry of Ayush, Govt. of India sanctioned vide CCRAS office order HQ-PROJ011/91/2022-PROJ/774 dated 04 November 2022) to Dr. Sachin Bansal, Principal Investigator (AIIMS Bhopal) and Assistant Professor in the department of Medical Oncology & Hematology at AIIMS Bhopal.

A. Recruitment for the post of Senior Research Fellow/ SRF (Ayurveda)

1. Number of posts: 1 (UR)
2. Consolidated Pay: **Rs. 41,300/-** (consolidated)
3. Age: 35 years or less
4. Duration of contract: 2 year (subject to continuation of funding by CCRAS, New Delhi and performance of the employee). The appointment will be on temporary basis for a period of one year. Based on the performance in first year, the appointment could be extended till the end of the project.
5. Qualifications (Essential):
Graduate Degree in Ayurveda (B.A.M.S.) from any recognized University. Preference will be given to those who possess higher qualification or who have previous research experience i.e having worked for any funded research project.
6. Qualifications (Desirable): Post-graduate degree in Ayurveda (Clinical Subjects), degree/ diploma/ certificate course in research methodology/ ethnography/ data analysis/ database management/ healthcare management.

Experience (Desirable): Previous experience of working on Clinical trial or tribal health care related projects or any project funded by the Ministry of AYUSH, ICMR, DST or equal organization, paper published in indexed biomedical journal as a first/corresponding author. 12th pass in science and 2years diploma of medical laboratory technician / B.Sc. (MLT)/B.Sc. Life Sciences with MLT (03 years)
