<u>Note-1:</u> The panel may remain valid for a period of three months from date of publication of result and may be cancelled/invalidated earlier without assigning any reason. Candidates who have completed 3 years tenure as Junior Resident in Govt. Institution need not to apply. Junior Residents who are already working in any Govt. Institution shall apply through proper channel. The total period, however, should not exceed the maximum period of three years.

NOTE-2: At the time of Interview the candidates should bring along with them Original plus Attested copies of MCI/State MC Registration, Educational qualifications certificates/mark sheets from Matriculation or equivalent onwards, Experience certificate (if any), Proof of Age (Matriculation Admit Card/certificate), Caste certificate (in case of OBC candidate, updated OBC certificate in Govt. of India Format to be submitted). Disability Certificate from Competent Authority, 2 recent passport size photographs and filled up Annexure- II & III (Candidates are advised to apply in not more than two departments).

CRITERIA OF INCOME & ASSETS (For Economically Weaker Section or EWS):

Persons who are not covered under the scheme of reservation for SCs, STs and OBCs and whose family has gross annual income below **Rs. 8.00 lakh (Rupees eight lakh only)** are to be identified as EWSs for the benefit of reservation. Income shall also include income from all sources i.e. salary, agriculture, business, profession, etc. for the financial year prior to the year of application.

Also persons whose family owns or possesses any of the following assets shall be excluded from being identified as EWS, irrespective of the family income:-

- i. 5 acres of agricultural land and above;
- ii. Residential flat of 1000 sq.ft. and above;
- iii. Residential plot of 100 sq. yards and above in notified municipalities;
- iv. Residential plot of 200 sq. yards and above in areas other than the notified municipalities.

The property held by a "Family" in different locations or different places/cities would be clubbed while applying the land or property holding test to determine EWS status.

The term "Family" for this purpose will include the person who seeks benefit of reservation, his/her parents and siblings below the age of 18 years as also his/her spouse and children below the age of 18 years.

INCOME AND ASSET CERTIFICATE ISSUING AUTHORITY AND VERIFICATION OF CERTIFICATE:

The benefit of reservation under EWS can be availed upon production of an Income and Asset Certificate issued by a Competent Authority. The Income and Asset Certificate issued by any one of the following authorities in prescribed format as given in **Annexure-I** shall only be accepted as proof of candidates claim as belonging to EWS:-

- i. District Magistrate/ Additional District Magistrate/Collector/Deputy Commissioner/ Additional Deputy Commissioner/1st Class Stipendiary Magistrate/Sub-Divisional Magistrate/Taluka Magistrate/Executive Magistrate/Extra Assistant Commissioner.
- ii. Chief Presidency Magistrate/Additional Chief Presidency Magistrate/Presidency Magistrate.
- iii. Revenue Officer not below the rank of Tehsildar.
- iv. Sub-Divisional Officer or the area the candidate and/or his family normally resides.
