Brief description of Project	Social media information, which sometimes is deftly manipulated by current AI tools, such as deep learning, to generate fake news, misinformation, and disinformation, takes advantage of the unsuspecting gullibility of the end-users and has a great potential to manipulate their belief systems. Potential abuse of such manipulated information poses a veritable threat to individual privacy and social peace and cohesion in the present information age. The present study strives to make a more holistic attempt to equip ourselves against such a threat. It will try to better understand the psycho-social impact of technologically manipulated information on social media users, at both individual and group levels, and will bring out the potential ethical implications of the problem. It also will try

		to understand the role the socio-cultural factors play in heightening the credibility and consequently causing such manipulated information 'to go viral'. On the other hand, it will try to capture the principles, the motivation, and the strategies of the social institutions and organizations which work against such misinformation/disinformation, and verify the information for its factual authenticity, and identify the possibility of technological manipulation. Finally, it aims to come up with policy recommendations and a set of interventions.
10.	Job Description	This position will require assistance in literature survey, data collection - analysis, and administrative aspects of the project.
