General Instructions:

- 1. Candidates who wish to appear for the above mentioned post may download the application form from the website of ICMR-NIRRCH, Mumbai. Candidates are requested to fill the application form and bring all the original certificates of educational qualification (Degree Certificate/Statement of marksheets), Caste Certificate, Caste Validity Certificate and Valid Non-Creamy Layer Certificate as on date (as the case applies), experience certificates, etc., along with one set of Xerox of the same duly self-attested and a recent passport size photograph for attending walk in interview. No need to send hardcopy of application form to ICMR-NIRRCH, Mumbai by post.
- 2. Age relaxation is admissible to SC/ST/OBC candidates in respect of posts reserved for respective category only and not for unreserved post as per GoI rules. The post reserved for SC/ST/OBC, Candidates are requested to kindly bring along the valid caste certificate/validity/valid non-creamy layer as on date (as the case applies).
- 3. Qualification/degree should be from a reputed Institution/University.
- 4. Mere fulfilling the essential qualification/experience does not guarantee for selection.
- 5. Canvassing in any form will be a disqualification.
- 6. No TA/DA will be paid either for attending the interview or joining the post.
- 7. Persons already in regular time scale service under any Government Department / Organizations are not eligible.
- 8. If required, written test in the subject area will be held to shortlist candidates for the interview depending upon the number of candidates.
