#### Engagement of Special Public Prosecutor (SPPs) at Bhopal

Applications from advocates having experience in Direct Taxes matters are invited by the Income Tax Department, Bhopal for engagement as Special Public Prosecutors (SPPs) to represent the Income Tax Department before Courts of Session and its subordinate Courts at Bhopal & other judicial fora. The eligibility criteria and other terms and conditions will be governed by the Instruction No. 6/2016 dated 07.09.2016 in F.No. 279/Misc./M-77/2011-ITJ issued by the Central Board of Direct Taxes, New Delhi.

2. The advocates desirous of and eligible for the post, in terms of the above said Instruction may submit their application in prescribed form in the O/o the Pr. Chief Commissioner of Income Tax, MP & CG, Bhopal **by 20.10.2023 till 05.00 P.M.** The format for the application, terms and conditions etc. may be downloaded from the official website [www.incometaxindia.gov.in](http://www.incometaxindia.gov.in) and/or also may be obtained from Asstt. Commissioner of Income Tax (Tech.), O/o the Pr. Chief Commissioner of Income Tax, MP & CG, Aayakar Bhawan, Hoshangabad Road, Bhopal.

#### 3. **Qualification of Special Public Prosecutors**

In order to be eligible for engagement as an SPP, a person should:

**(a) be eligible to appear before the court as an Advocate and**

**(b) have a minimum experience of 7 years as a Practicing Advocate, in criminal matters.**

**Adequate experience of handling trials relating to Direct Taxes is desirable.**

4. For the purpose of experience as mentioned in the CBDT Instruction No. 6 of 2016 dated 07.09.2016, the cut-off date for eligibility will be the date of the present advertisement.

5. Applicants are required to submit fresh applications for engagement of Special Public Prosecutors(SPPs) at Bhopal. The applications received earlier to this advertisement or received through any other channel or received after the due date are liable to be rejected. Applications deficient in any respect shall also be summarily rejected.
