(i). <u>Communication Officer in the Office of the Principal Regional Health & Family Welfare</u> Training Centre Under the Directorate of Health Services (MCH&FM).

The candidate must be a Master Degree in Mass Communication & Information from any recognised Institutions/University.

(ii). Social Science Instructor in the Office of the Principal Regional Health & Family Welfare Training Centre Under the Directorate of Health Services (MCH&FM).

The candidate must be at least a 2nd class Master Degree in Social Science, Social work or Education with experience in teaching or Social work including Family Planning. Persons having special training in Family Planning is preferred.

PARA. 3: Age & Age Relaxation:

PARA .8: COMMISSION'S DECISION ON ELIGIBILITY OF CANDIDATES
