#### NOTICE INVITING APPLICATION FOR VETERINARY OFFICER

Applications are invited for engagement of **One Veterinary Officer** with a monthly fixed remuneration of **Rs.65,000**/ -at Nabarangpur Forest Division, Nabarangpur, Odisha. The engagement is purely temporary and is initially for a period of one year which may likely to continue for next year(s) subject to satisfactory performance followed by execution of agreement.

**Essential Qualification:** Applicant must have consistent good academic career with B.V.Sc./M.V.Sc. in Veterinary Science and Animal Husbandry from a recognized university. Fresh B.V.Sc. candidate or retired Govt. servant having above qualification may also apply for the above post.

**Desirable Experience:** Candidate must have minimum 1(one) year Experience as Wildlife Veterinarian.

Age Limit: Upper age limit is 65 years as on 01.011.2023.

## **Duties of Veterinary Officer:**

- 1. Treatment of different cases of wild animals at the rescue centre.
- 2. Referral of complicated cases to the concerned Chief District Veterinary Officer/ College of Veterinary Science and Animal Husbandry, OUAT, Bhubaneswar.
- 3. Early detection of communicable & non-communicable diseases.
- 4. Tranquilization/sedation of wild animals.
- 5. Curative treatment to sick/injured wild animals.
- 6. Reviewing/monitoring preventive vaccination of livestock & poultry in forest areas.
- 7. Creation of public health awareness.
- 8. Examination of Fecal Sample (F/S), Blood Sample (B/S), Urine Sample (U/S), Skin Scrapping (S/S).
- 9. Collection of both ante mortem & post mortem samples & their subsequent delivery to referral laboratory for further diagnosis.
- 10. Provision of healthcare services at times of diseases outbreaks/ natural calamities.
- 11. Sensitization of farmers about bio security measures by conducting village meetings and using suitable Information, Education & Communication (IEC) materials like leaflets/pamphlets.

#### **Other Conditions:**

- Duration: The engagement of the Veterinary Officer is for a period upto twelve (12)months. The engagement may be renewed on the basis of performance as decided by Divisional Forest Officer, Nabarangpur.
- 2. Working hours: The Veterinary Officer will be expected to be on duty in Office opening to closing hours. The candidate may be required to work on off days and beyond duty hours on the discretion of the Divisional Forest Officer, Nabarangpur Forest Division with mutual agreement.
- 3. Leave: The candidate is allowed for 15days casual leave per year with prior permission of Divisional Forest Officer, Nabarangpur Forest Division.
- 4. **Remuneration:** Total remuneration per month will be Rs.65,000/- which is all inclusive of House Rent Allowance and other benefits.

5. The Office is under no obligation to continue the engagement and may discontinue the engagement with one(1)month prior notice, without assigning any reason hereof.

 The Veterinary Officer will not use or share any data related to Nabarangpur Forest Division to outside the organization without prior permission from the authority.

Selection procedure: Selection will be based on the previous field experience and performance in the interview. Candidate having similar work experience/ knowledge of working in Forest Department will be given preference. Candidates should bring the duly filled-in applications with self-attested true copies of testimonials of educational qualifications, certificates, work experience, proof for date of birth, category etc., along with copies of mark sheets of all examinations and 'No Objection Certificate' from present employer (if employed) to Divisional Forest Office, Nabarangpur Forest Division At/Po- Nabarangpur, Dist-Nabarangpur on the date of interview. Applicant will submit the undertaking that they will be able to join their place of work within 7 days of issue of letter of acceptance. A brief write up on previous experience should also be submitted alongwith the application. After registration and scrutiny of the application, the candidates will be interviewed for selection on the scheduled date i.e., on 24.11.2023.
