3. Date of determination of eligibility will be the date of Interview (21.03.24).

4. Candidates must produce all relevant documents related to their qualifications & experience in original during interview. Candidates not producing **theOriginal** Certificates will not be considered.

5. The post is purely temporary on contractual basis. The appointment will be initially for a period of **6 months** which may be renewed depending on performance of the candidate and extension of the project from the funding agency.

6. The assignment will be governed as per the rules / instructions received from the ICMR / competent authority from time to time. This appointment will not vest any right to claim by the candidate for regular appointment or permanent

absorption in NEIGRIHMS or ICMR or for continued contractual appointment.

7. The contractual appointment gets terminated on the completion of the project or can be terminated at any time by either side by giving 30 days' notice or salary in lieu thereof.

8. Leave: The leave entitlement of the appointee shall be governed in terms of the ICMR leave policy governing extramural research projects as amended from time to time.

9. Attempts (direct/indirect) to influence the Selection Committee in any way or form will lead to disqualification of the concerned candidate from the recruitment process.
