Short-term stay in furnished campus Guest House is available with nominal charges; multiple cafeterias for reasonably wide verities of food options are available in-side the campus.



### 1. Remuneration for the said appointment:

- (a) Part Time Appointment:

- (ii) No private practice is allowed in any capacity after joining in Full Time assignment as Super Specialist at ESIC Medical College, Bihta, Patna- 801103.
- (iii) The contractual engagement may be terminated/ discontinued from either side giving one-month prior notice to this effect without assigning reason. In case of spot resignation, one month's salary is to be deposited to ESIC Account through Challan.



- (iv) The selected specialist must have a professional indemnity policy of Rs. 30,00,000/- (Thirty Lakhs) only which should cover the period as desired by ESIC. The policy is meant to cover the profession liability falling on them as a result of errors and omissions committed by them while rendering professional services.
