The essential qualification for these positions is Ph.D., however those who have submitted their thesis and waiting to defend their thesis are also eligible to apply. Recruitment of such faculty will be done using guidelines issued by MHRD vide reference No. 27-11/2011-Ts-I, dated 23rd April 2014 will be followed.

2. The appointments of Assistant Professors (Temporary) are for one year on contract, with monthly consolidated pay of Rs 70,000/- if PhD is awarded. However, those who have submitted thesis may also apply; till their PhD is awarded, their consolidated pay is kept at Rs. 65,000/-.
3. A detailed Profile, inter alia, including the following information is required to be submitted: A Teaching Plan, indicating industry-oriented skill-based courses from the curriculum of IIITDM Kurnool (available at www.iiitk.ac.in) that the applicant can teach and also an expanded statement of his objectives and long-term interests in coursework development.
4. All the selected candidates are expected to work by taking academic responsibilities on full time basis on par with the regular faculty members of the Institute.
5. Details of publications/Patents: Candidates are expected to submit a list of journal publications and patents, if any.
6. Details of Awards, Patents, Prizes etc., indicating: Nature, Name of prize/award, awarded by, awarded for, year of award; Name of the patent, year and details about the patent, etc. as well as the candidate's specific contribution along with Co-inventors.

7. Non-refundable application fee of Rs 500/- is to be paid in the form of Demand Draft in favour of "Registrar IIITDM Kurnool". SC/ST, PwD, and Women candidates are not required to submit the application fee.
