Applications are hereby invited from the prospective candidates through Regd. Post/Speed Post in the prescribed proforma which is available on the website i.e <https://rayagada.odisha.gov.in> from 26th June to 19th July, 2024 for selection of two Fellows in Aspirational Blocks. Engagement of the selected candidate will be for a contract period upto October, 2024. The Complete and closed cover applications shall reach to the Office of the CDO-cum-EO, Zilla Parishad, Rayagada, PIN-765001.

The post is purely contractual for execution of project work under Aspirational Block Programme (ABP) & co-terminus with the ABP Programme. The selected candidates shall be posted in two Aspirational Blocks i.e. Muniguda Block and Padmapur Block of Rayagada District.

N.B:- Preference will be given to candidates who have completed their higher education in the development/rural stream.

3. AGE: A candidate must be within in the age of 22 to 45 years as on 01.01.2024. Date of Birth entered in the high school certificate or equivalent certificate issued by the competent board/council will only be accepted.

4. METHOD OF SELECTION:

The selection of candidate for recruitment to the posts will be made on the basis of following selection process:

- (i) **Computer Knowledge Test:** 50(Fifty) Marks.
- (ii) Those who will secure minimum 30 marks in the Computer Test shall be eligible to appear the Personal Interview.
- (iii) **Personal Interview** :The Personal Interview shall be of 50 (Fifty)marks for shortlisted candidates.

On the basis of marks secured by the candidate in all the above tests, merit list shall be prepared for the post advertised and the same shall be published.

- iv) All applicants should produce their academic certificate and experience certificate (if any) along with the application form in the prescribed format.
- v) The selected candidates should produce two character certificates from two different gazetted officers at the time of certificate verification.
- vi) **Original Certificates/documents to be produced during verification.**

Only those, who are called for document verification, will be required to submit the true copies of the following documents duly self-attested by candidate with their full signature along with original certificates, mark sheets etc. for verification on the date fixed by the Zilla Parishad, Rayagada.

5. Role of Aspirational Blocks Fellows:


The Aspirational Blocks Fellows will be positioned as a critical link between the block level Officials and NITI Aayog. Their primary responsibilities will include:

- a) Collaborating with Block level Officials to design and execute development strategies aligned with ABP thematic areas.
- b) Conducting regular field visits to assess project implementation, address challenges, and collect ground-level insights.
- c) Analyzing data and providing evidence-based recommendations to BLOs, District level Officials to optimize developmental initiatives.
- d) Organizing workshops, awareness campaigns, and skill-building programs to empower the local community.
- e) Keeping States and NITI abreast with the issues, challenges and need for support.

6. Benefit and Impact:

The deployment of Aspirational Blocks Fellows is expected to yield multiple benefits:

- (i) Strengthening governance and administrative capabilities at the Block level.
- (ii) Enhancing the efficiency and effectiveness of developmental projects.
- (iii) Enabling knowledge transfer and cross-learning between the fellows, officials, and local communities.
- (iv) Contributing to data-driven policy formulation and evidence-based decision-making.
- (v) Building a talent pipeline of future leaders committed to social impact and community development.




7. Tenure of Aspirational Blocks Fellows :

The tenure of Aspirational Blocks Fellow will initially be upto October-2024, during which they will actively engage with Block level officials to drive developmental initiatives and empower local communities. Recognizing the potential for sustained impact ,the program allows for a one-year extension of the fellowship, contingent upon the fellow's satisfactory performance and demonstrated contributions to the Programs's objectives, as determined by the Sate Govt.

8. TERMS AND CONDITIONS

- a) The applicants need to paste their passport size photograph and put their signature at the appropriate place in the application form and send it to the specified address along with attested photocopies of required certificates and all other documents by **SPEED POST/ REGISTERED POST only**. Application froms sent through any other means will not be accepted.
- b) Submission of only hard copy of application to the **CDO-cum-EO,Zilla Parishad, Rayagada, Pin-765001 by 5.00 PM from 26.06.2024 to 19.07.2024**
- c) Short listing of eligible candidates will be done by the screening committee under the Chairmanship of Collector-cum-CEO,Zilla Parishad/CDO-cum-EO,Zilla Parishad,Rayagada **on 20.07.2024**
- d) Candidates satisfying eligibility criteria will be taken forward and candidates not matching eligibility criteria will be eliminated from the process.
- e) List of Shortlisted candidates along with the list of rejected candidates with reason will be published on the website of Rayagada district on **20.07.2024**
- f) Shortlisted eligible candidates will be invited for the Computer Test and Personal Interview (PI) on dated **25.07.2024** at Zilla Parishad, Rayagada from 10.30 A.M. onwards.
- g) **No TA/DA will be given to any candidate to attend recruitment process at any stage.**
