### **Terms and conditions**

- 1. The period of contract for the post of Full Time/Part Time Specialist will be initially for a period of one year extendable upto total period of three year based upon satisfactory work performance.
- 2. The appointing authority reserves the right to terminate the appointee anytime even before the tenure on joining of regular incumbent or without assigning any reason by giving one month notice. Similarly, the engaged person will have to give one month prior notice before resigning or will have to pay an amount equivalent to one month's remuneration in lieu of the notice period.
- 3. Other terms and conditions will be applicable as issued by ESIC Hqrs. From time to time.
- 4. For Full time specialist private practice of any kind will not be allowed.
- 5. Full time specialist will be available 24x 7 on emergency calls.
- 6. No TA/DA will be admissible for joining and other purpose.
- Candidates selected for engagement will have to execute a contract on a stamp paper of Rs. 1000/-. The original contract will be with ESIC Model Hospital Phulwarisharif, Patna and its copy will be with candidate. Cost of the stamp paper will be borne by the candidate.
- 8. The Selected specialist must have a professional **Indemnity policy/bond** which should cover the period as desired by ESIC in the bid. Policy is meant to cover professional liability falling on them as a result of error and omissions committed by them while rendering professional services. The minimum sum assured per annum should be Rs. 20 Lakh for Otorhinolaryngologist (ENT) and Ophthalmologist (Eye). 2. Rs. 10 Lakh for Radiologist and Pulmonary Medicine etc. A copy of the **Indemnity policy/bond** must be submitted within 7 days from the date of engagement.
- 9. Full Time/Part Time Specialist will be assigned duty by the Medical Superintendent of ESIC Model Hospital Phulwarisharif, Patna or their representative.
- **10.**Full Time Specialist will be entitled for the leave @ 04 Days for each month of work on pro rata basis in a calendar year. In the event the specialist prefers not to avail the leave the same may be encashed to a maximum limit of 30 days/year.
- **11.** Medical Superintendent reserves the right to cancel recruitment/increase/decrease vacancies as per actual requirement on the date of Interview.
