- 5. Candidates should bring following self-attested copies of the relevant certificates/testimonials along with the original certificates/documents.
  - a) SSLC Certificate/Marksheet
  - b) National Trade Certificate
  - c) Govt.Identity Card (Aadhar Card/Driving License/Voter ID, etc.)
- 6. No travelling or any other allowances is admissible for attending the written test/interview.
