- 1. Qualification:** MBBS with P.G. Degree/Diploma/DNB in the concerned specialty from a recognized University / Institution and should have a valid registration with Delhi Medical Council. Must have not completed 03 years Senior Residency in any recognized institution including regular & adhoc period.
2. In case of non-availability of candidate with PG Degree/Diploma, candidate with three years experience in the respective specialty will be considered.
3. In case of non-availability of fresh candidates, the candidates who have completed 3 years of Sr. Residency may also be allowed to appear in the interview.
4. **Pay scale:** Rs.67700 – 208700 of level 11 plus allowances as admissible under the rules.
5. **Age limit for Senior Residents:** 45 years for Gen. and OBC candidate and age relaxation for SC/ST candidate as per rule.
6. **Other conditions/requirements:**
 1. OBC/EWS certificate issued by Govt. of NCT of Delhi shall only be accepted and the same must have issued before the date of interview. Further, the OBC certificate must possess Non Creamy Layer certificate for the current year along with his/her caste certificate.
 2. Candidates are required to bring all original certificates and testimonials along with two passport size photographs on the date of interview.
 3. No TA/DA will be paid for appearing in the interview.
 4. Hostel accommodation is mandatory for selected candidates subjected to availability.
 5. Number of the vacancies is provisional and subject to change without any notice.
 6. In case of non-availability of candidates under SC/ST/OBC/EWS category, vacancies may be filled up from the General category.
